I, HARIPRASAD KHETAN hereby certify that the paid up Equity capital of the Company is Rs. 48,579,000/- (Four Crores Eighty Five Lakhs Seventy Nine Thousand only) and the net worth of the company was Rs **39,213,888/-**(Three Crores Ninety Two Lakhs Thirteen Thousand Eight Hundred and Eighty Eight only) as on 31.03.2018.

And as per Regulation 15 (2) of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 corporate governance provisions as specified in regulations 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27 and clauses (b) to (i) of sub-regulation (2) of regulation 46 and para C, D and E of Schedule V shall not apply to the following class of companies:

Accordingly it may be noted that the paid up share capital of the Company is below Rs. 10 crore and Net Worth of the Company has not exceeded Rs.25 crore, as on 31<sup>st</sup> March, 2018 and hence **Corporate Governance is not applicable to the Company.**
